


They began investigation, and after working with multiple victims, including me, and reviewing court documents (civil suit records for fraud, faking cancer, theft, harrassment, stalking, and related, as well as criminal court transcripts in which Kris pleads guilty/nolo contendre to embezzlement: theft of a human skeleton), ABC 10 News decided to proceed forward.</p> <p>ABC 10 News will be airing an investigative piece on Kris and the damage she has wreaked on the SAR community, and pit community. There are multiple victims who are speaking out, on camera.</p> <p>They are already running clips, showing multiple pictures of Kris, and calling her the story that had all the makings of a "hero", but instead turned into a "massive fraud, con artist, and sociopath".</p> <p>ABC 10 will be offering the story live on Wednesday night, 11 news, in addition to sharing with affiliate stations who had victims in their area, and or cooperated in the investigation, as well as offer feed to ABC national and CNN. This is not about pit bulls. Her dogs are lovely dogs. The breed is one I love - I adopted a very geriatric bully from PBRC, and kept him until he passed. This is solely and strictly about a woman who is pillaging good people in both the SAR community and the pit community for her own personal gain.</p> <p>Kristine Crawford's personal strategy, as will be aired tomorrow night, is to befriend good people who have something to offer - reputation, money, prestige, whatever it is she needs, or thinks she needs. Then, after befriending them, Kris begins to recite her tales of woe: being evicted because she has pits; that there are people trying to steal her dogs; that her dogs have been poisoned; that coworkers or teammates or others in the community are jealous of her, and are trying to ruin her; that she is dying of cancer and lupus, and has no one to take care of her.</p>

Slowly, little by little, she works her way into your home, your pocket. She will drive hours to seek refuge at your home, for care, but be too weak to make it from the car to the door. Too weak to eat, she'll have you help feed her. Then, bravely, valiantly, she'll make it home, because she has some duty or mission to attend to - but she'll return....

And when stories don't add up, when lies begin to conflict, she'll turn vicious. She'll make up names, or steal real people's identities. She'll send you email under their names; Fed Ex letters to your work; accuse you of horrible acts, crimes. She'll mail pictures, letter, accusations about you to your spouse, to your employer.

And that's just the beginning of her retribution, when you figure out what she's doing.

Civilly, specifically, Kris Crawford has been accused of the following:

Fabricating the story of how Dakota was originally a bait dog

Fabricating the story of how Tahoe was a Dumpster dog

Fabricating stories of injury and or poisoning of her dogs for financial gain

Fabricating the stories of Cheyenne as a search dog

None of these stories are true.

Claiming that her father was killed at 9/11

Claiming that her father was injured at 9/11, and later died on 12/21

Claiming that it was not her father who was killed, but her stepfather

Claiming that her father is still alive, but a double amputee due to injury at 9/11

Kristine Crawford's father is very much alive with both his legs.

Inventing a husband, a doctor, who was killed by a drunk driver

Inventing a husband, a doctor, who was injured, in a coma, and later died from injuries sustained while mountain climbing

Kristine Crawford has never been married.

Pretending to be severely debilitated by systemic lupus

Pretending to be dying of stomach cancer

Pretending to be dying of lymph cancer

Pretending to be dying of lung cancer

Pretending to be dying of cancer located in her sartorius muscle

One month, and two days before she was supposed to be dead (Christmas, 2004), Kristine injured herself while trespassing (the injury is believed to be intentionally self inflicted), she was transported to Palomar Hospital Emergency Department, Escondido, California, where she told admitting doctors that her "cancer and lupus" were irrelevant, and the diagnoses that were written on her intake forms were to be taken off.

These are only a few of the provable and documented frauds that Kristine R. Crawford has been perpetrating, and of which have been repeatedly accepted by separate judges in a civil fraud case that was heard this year in San Diego Superior Court.

In that civil case, Kris was accused - and found civilly liable - for fraud, theft by deception, faking cancer for financial gain, for harassment, of creating fictitious identities for the purpose of harassment, of computer website intrusion, and more. She was found liable on all counts.

There are known victims throughout the country, and many have stepped forward, including on camera, for this investigation that will be aired on Wednesday, May 24, 2006, ABC San Diego, News 10, www.news10.com.

Criminally, Kris was arrested in August, 2005, and charged with two counts of embezzlement for the theft of a human skeleton, stolen from the Biology Department of Menlo College, and for the theft of a Fender Passport amplifier system, stolen from the Menlo College Music Department.

She did not steal the skeleton for the purpose of her cadaver training: instead, she took the skeleton to the home where she lived, borrowed her landlord's Vespa, posed the skeleton on the Vespa, including a staged crash, as well as posed the skeleton wearing sunglasses, holding a

Pepsi and sunflower seeds while laying on a back yard chaise lounge. She also took the skeleton to her place of employment, and staged the skeleton on a school bus in a seat, and then again, with the skeleton face down, outside the door, with a woman shaking her finger at the skeleton. She then created a two page website and entitled it "Skully's Adventures", and incorporated music into the webpage.

Atherton Police recovered the skeleton from her property, after interviewing her (she denied it), and serving a search warrant. The skeleton was then recovered, as was the amplifier system.

It is important to note that Kris claimed that Menlo College gave her the skeleton because she was so weak with her cancer, that she could not do as much search and rescue field work, and this would allow her to teach more classes. She also claimed to have been given the amplifier, because the tumor in her lung had grown so large, she could not project her voice any more.

Neither of those claims, of either the "gifts" or the cancer, are true in any way.

She has, since her arrest, claimed multiple different stories, including that others stole it, that she stole it for someone she loved, that she didn't know it was stolen, and, lastly, that she was framed.

After multiple delays, and changes several times in attorney's, Kris was finally in court this month, where she pled guilty/nolo contendre to the theft.

She is due to be sentenced next week. The prosecution is seeking thirty (30) days in jail, but she *COULD* be sentenced to a year.

Kris Crawford often claims that she is the victim of relentless persecution, of jealous dog owners, of the victim of hatred by people who are out to destroy the pit bull.

She has claimed that one woman, an attorney, purposely lost a case Kris was involved in, as retaliation, because Kris would not let her use her 'super secret sensitive NASA Shuttle' search information in this woman's book.

She claims that dog fighters are seeking her, and her dogs, to make thousands in a dog fight that would 'kill the SAR pits'.

She has claimed since last November to be in hiding by the federal government, in witness protection, for her "undercover federal SAR work".

She has claimed that well established pit bull rescuers, like Tia Torres, are jealous, and therefore, out to "destroy Kris" so they can get more money for their own use.

Don't believe any of it. Do not donate to Kris Crawford. She is not what she wants you to believe, and she never has been.







"The Backyard Breeder Fallacy

I own purebred dogs. Once a year or so I breed a litter from DNA profiled champion stock. For that, I will never apologize as I truly have the best interest of my chosen breed foremost in my mind. Am I an elitist? You betcha! Would I cringe if you went so far as to call me a dog Nazi? No. Serious breeders mate dogs of known background in order to reduce the chances of congenital defects and predict with greater accuracy the positive outcome of a planned litter of puppies. Therefore I probably seem like an unlikely advocate for the guy advertising puppies in the local newspaper. However, I am also a civil libertarian. And I won't apologize for that either.

Proposed, pending and contested legislation around the United States and abroad that is aimed at restricting our property rights by targeting animal reproduction has become rampant at every level of government. Forced spay and neuter, cost prohibitive licenses for unaltered dogs and breeding permits, micro chipping of our animals with their information (and ours) in government data bases, warrant-less inspection of our property, arbitrary limits on the number of animals we can responsibly care for and mandatory husbandry practices are some of the ways in which dog owners are being relieved of their civil rights.

While our agrarian forefathers did not specifically guarantee us the right to own and breed animals, they did guarantee us the right to be treated equally under the law, the right to own property, the right to be free from warrant-less search and seizure of that property, the right to due process and the right to commerce. With no respect for our Constitution, animal rights supporters are working hard to relieve us of these rights by packaging restrictive legislation in a way that is not only palatable to dog owners, even some breeders, but misleadingly leaves them with the impression that they have supported something beneficial. Far too many animal owners and welfare advocates are buying into it in one area or another.

Divide and conquer. By creating stereotypes and labels, like "puppy mill" and "backyard breeder" and attaching a stigma to those labels, the animal rights movement is trying to disgrace the act of breeding animals. And they're doing a great job. The media has been flooded with images of dogs being raised in cages, in filth, in neglect. Sad faces of shelter animals behind prison bars on "death row". Images intended to produce an emotional response instead of an intellectual one. And don't forget the staggering statistics.

It's not a secret that animal rights mean no more domestic animals. It's in their mission statements. HSUS president Wayne Pacelle brags that "We have no ethical obligation to preserve the different breeds of livestock produced through selective breeding. One generation and out. We have no problem with the extinction of domestic animals. They are the creations of human selective breeding". Allow me to translate, no animal breeding means no more animals. Period. And while the general public cannot be sold on such a radical concept, it's been surprisingly easy to sell them on the concept of ever tightening restrictions. Although united in our love of domestic dogs, slick marketing by the enemy has created infighting. Breeders both private and commercial, rescuers, shelter staff, animal control, dog show exhibitors and pet owners are cleverly being turned against one another to forward the animal rights agenda. Each believing that their point of view is the only valid one and everyone else's civil rights no longer matter.

Yes, I too personally find those images disturbing. They are the product of gross human negligence and irresponsibility. I love animals, I have been a shelter volunteer, and I believe in animal welfare but I am also a realist. Things are rarely what they appear on the surface. In order to end the animal surplus and related suffering, I want to get to the actual cause, to prevent the illness instead of treating the symptoms, so to speak.

The demand for a product (puppies, for example) is driven by the consumer. It's a simple case of supply and demand in a free market economy. Don't blame the seller for being an opportunist. It's only human nature flourishing in what is still a mostly democratic society. An uneducated consumer has every right to purchase an inferior product and suffer the consequences. Just as

the seller has every right to promote the benefits their product, in order to influence the decisions of the consumer. If breed purists and elitists like me are outraged at breeders who turn a profit by selling what we consider to be an inferior product, then we must only blame ourselves for failing to educate the buyers.

Ignore the propaganda; dog breeding is not the cause of shelter overpopulation. Animals end up in shelters for a myriad of reasons. Behavior problems that result from a lack of training and proper socialization along with normal breed characteristics that the owner finds unacceptable top the list. Owner death, job transfer/move, landlord/rental restrictions, insurance discrimination, financial trouble and the inability to comply with escalating pet ownership restrictions also contribute to the problem. The system is designed to perpetuate it.

We live in a disposable society. As long as domestic animals are viewed as a short term convenience, instead of a serious long term commitment then change is unlikely. The problem is one of perspective, information and education. Pointing fingers at each other is cowardly and counterproductive.

According to a 2005 article in the HSUS magazine All Animals, 75% of the shelter population is comprised of mongrels. Now I'm no math wizard, but I can extrapolate that only 25% must therefore be purebred animals. If this is true, then random bred dogs are the real cause of shelter overpopulation, not "puppy mills", breed enthusiasts or "backyard breeders" of purebred dogs. Yet this same HSUS article praises the mongrel as superior because of its' larger gene pool. One that may very well be polluted with unknown genetic defects. They even go so far as to market them as a "designer" product. Sort of a haute couture, one of a kind canine fashion accessory.

Now, it occurs to me that if you truly want to reduce the animal shelter population in a meaningful and dramatic way, than you should advocate for the elimination of the mongrel, through mandatory spay and neuter of random bred dogs with unknown ancestry. (See, I am a dog Nazi!) Most dog breeders know that you must have a firm grasp of the genetic past, in order to improve the genetic future of your line. Many of the minority purebred animals that end up in the local shelter may not have a known origin either, and are therefore not an ethical choice for perpetuation of their breed. The same "hybrid vigor" so highly touted in the mongrel is just as easily achieved by crossing healthy purebreds of known ancestry to create new breeds. Man has done so since the beginning of domesticated dog breeding and whatever we fancy, that breed was created by this process.

The beauty of purebred dogs is that there is something to appeal to almost anyone. I don't have to agree with your choice but I must respect your right to make it. I'm not going to advise that consumers rush out and purchase a Puggle, Labradoodle, or Cockapoo, anymore than I would suggest that everyone should select my preferred breed. (Not everyone deserves one!) Whether these designer hybrids stand the test of time or fade out with other trends is not for me to say. Freedom of choice means the freedom to make the wrong choice, and the freedom to make better choices in the future.

Am I a "backyard breeder"? Well, by technical definition I guess I am. I have also been a front yard breeder, a living room breeder and a cab of my motor home on the way to the dog show breeder. If that makes me a villain, then the animal rights lunatics and the terrorists who support their ideology win. But if you become an independent thinker, then freedom wins. We all win. "
